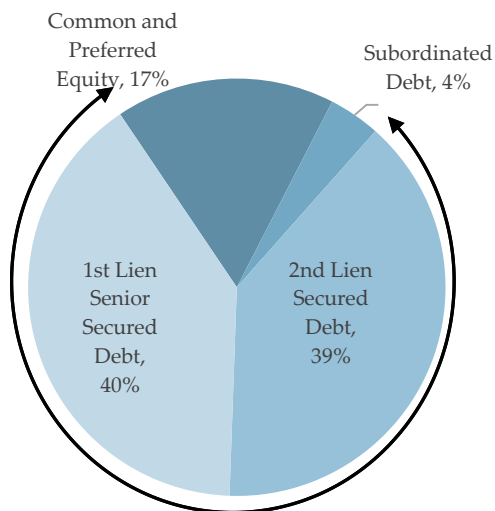

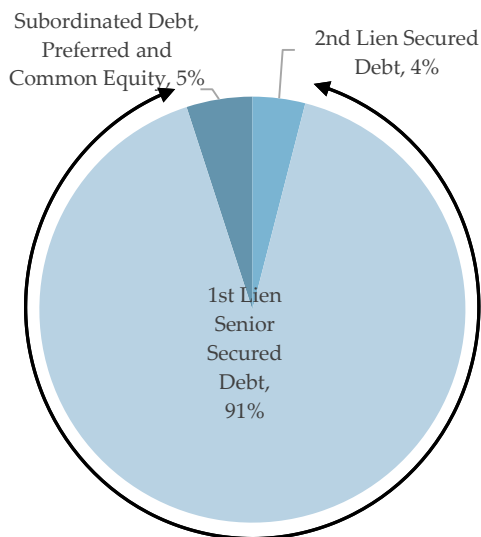

## Conservative Portfolio Construction

- 86 companies in 23 different industries
- Weighted average debt/EBITDA through PFLT security is 4.25x
- Weighted average cash interest coverage is 2.9x
- 91% of portfolio is first lien senior secured and 95% is secured
- 100% of portfolio is floating rate

## Consistent Performance & Track Record

- Low volatility of underlying portfolio EBITDA through the Great Recession

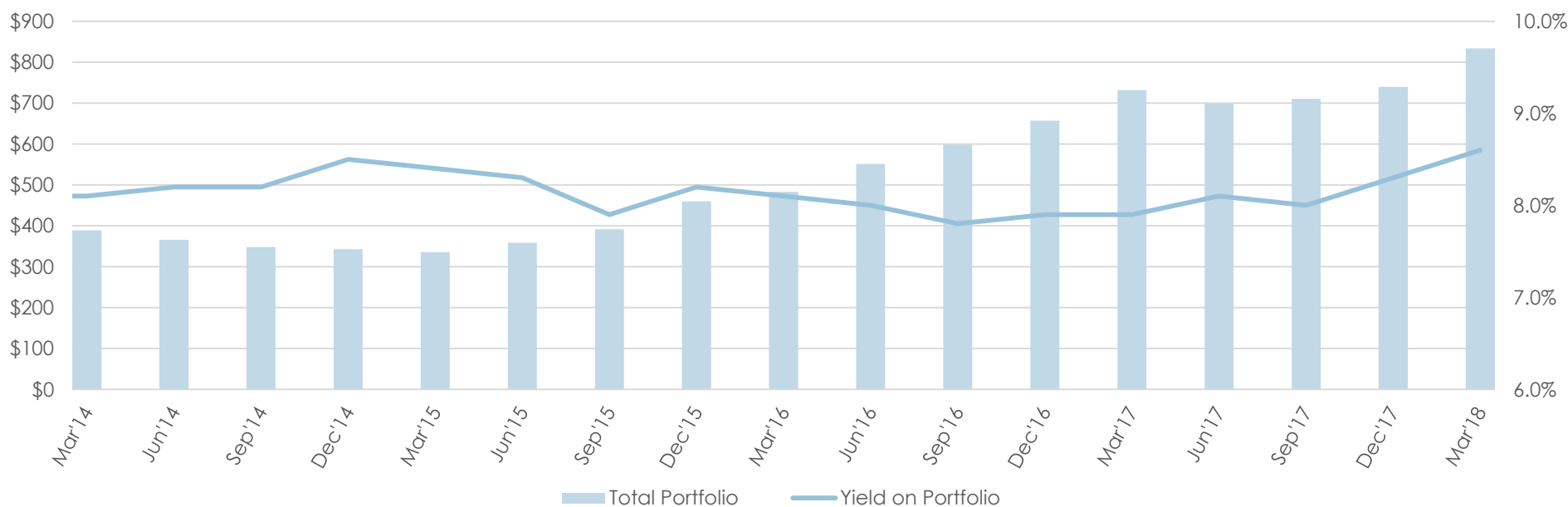

# PFLT has a Compelling Track Record

- ▶ Portfolio growth has been measured and consistent with market opportunity
- ▶ Prudent management has avoided growth simply to grow AUM
- ▶ Loss experience: about 10 bps annual net realized and unrealized gain since inception
  - Only 5 non-accruals out of 320 companies since inception
  - Strong track record of capital recovery – Blended recovery of 105% on non-accruals
- ▶ Consistent, steady dividend stream since inception

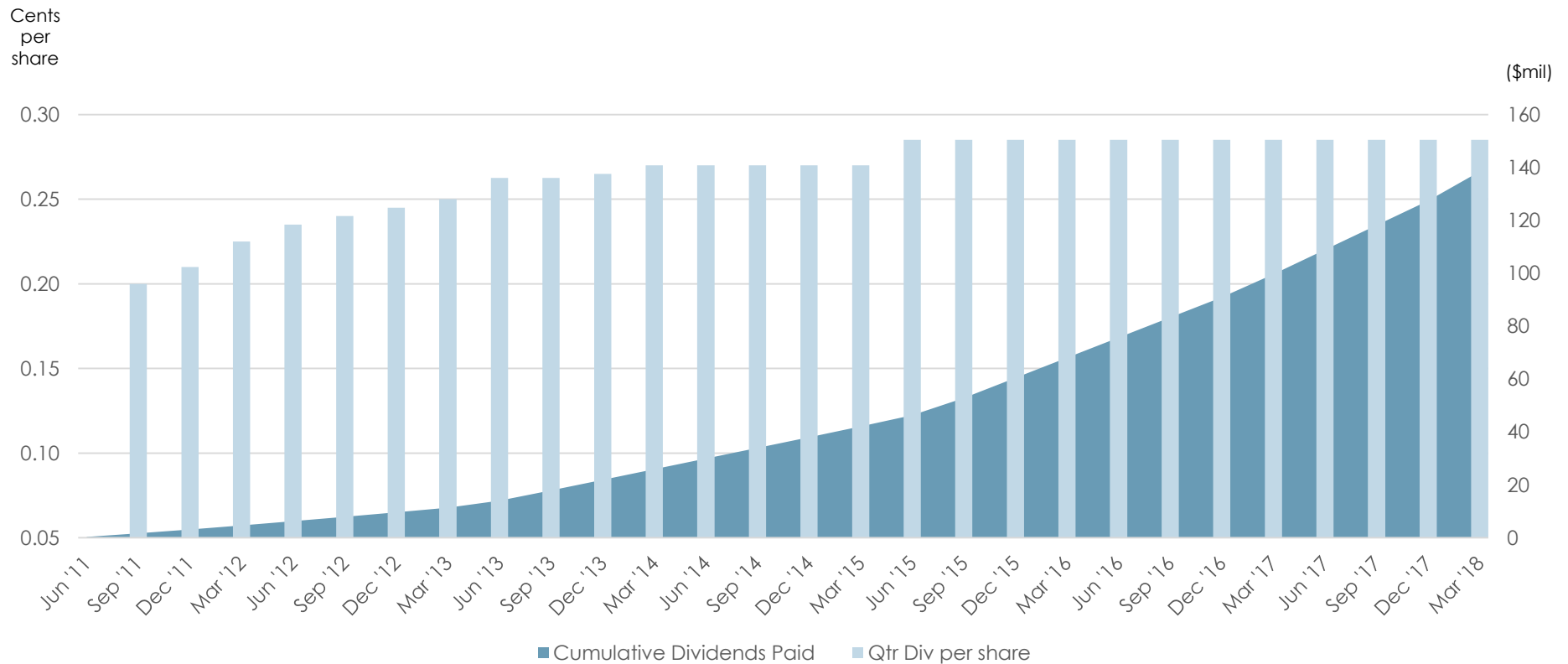
Portfolio Size (\$ in millions) and Debt Yield

Quarterly Dividends and Cumulative Dividends Paid

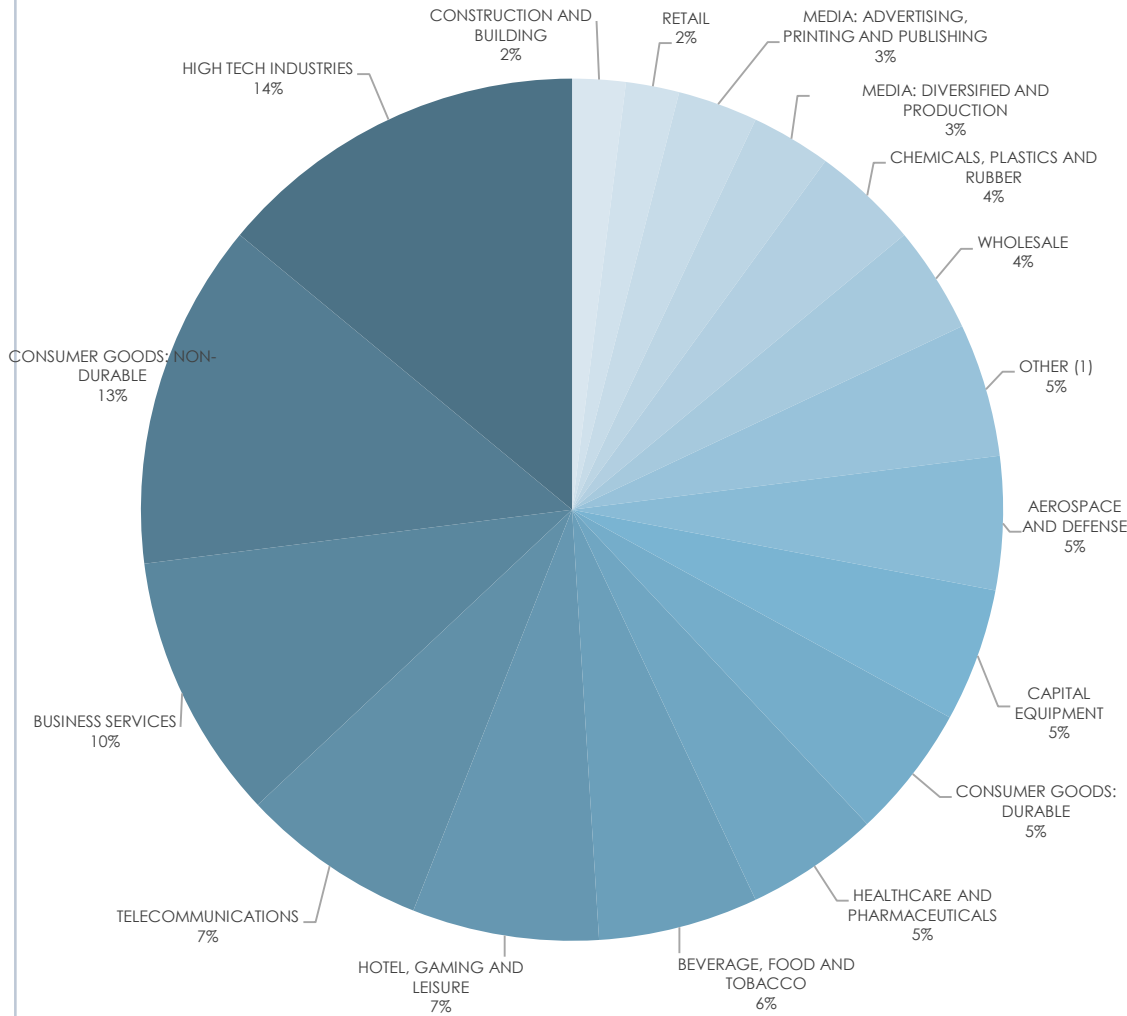




- ▶ Invests in primarily middle market, directly originated first lien loans
- ▶ \$630 million of total capacity
- ▶ Total commitments of \$210 million in First Lien Notes and Equity from PFLT and Kemper Corporation
- ▶ Up to \$420 million of third party debt financing
- ▶ Expands ability to serve sponsor and borrower clients with larger bite sizes
- ▶ Leads to higher ROE and NII per share for PFLT

## Highly Diversified Industry Mix

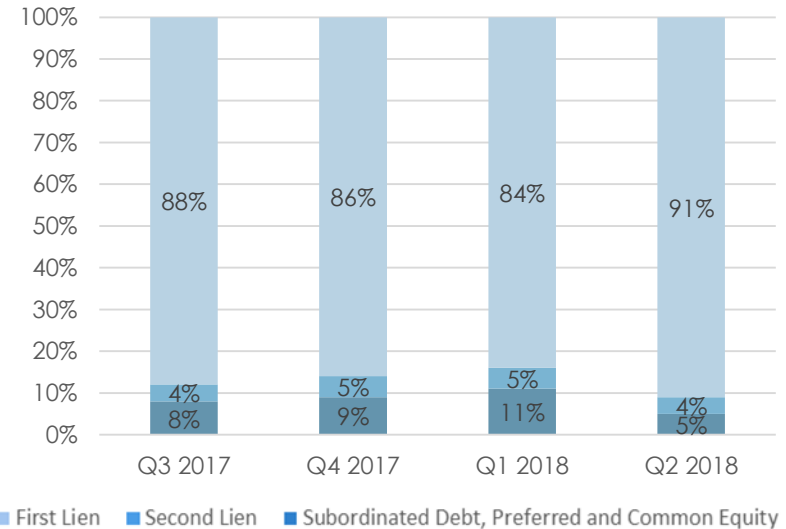

## Portfolio Mix

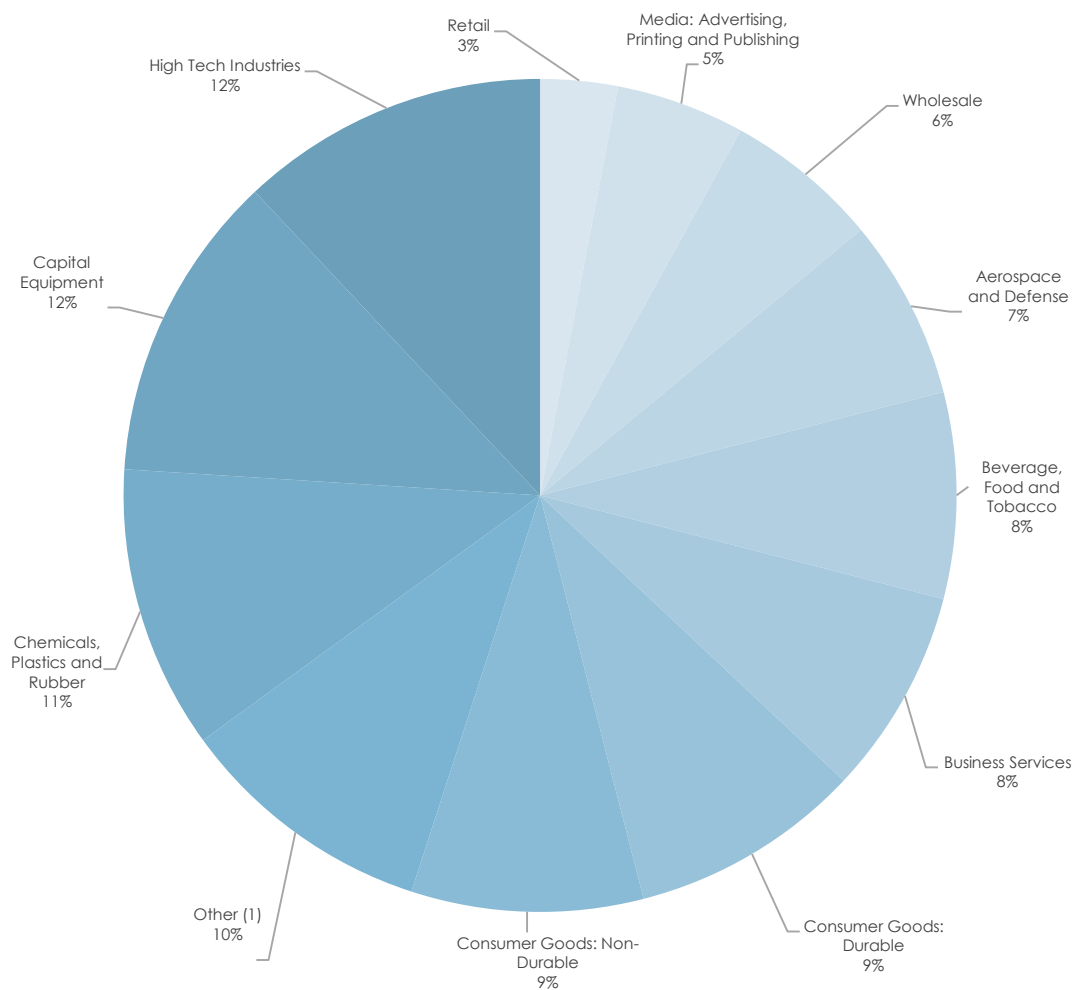
